# Public Housing Flat Rent Schedule

The new 2024 Public Housing Fair Market Rent (FMR) rates have been released by The U.S. Department of Housing and Urban Development, and are effective immediately with new admissions and recertifications issued $01 / 81 / 24$ or later.

Opportunity Home San Antonio will set the flat rental amount for each Public Housing unit that complies with the requirement that all flat rents be set at no less than 80 percent of the applicable FMR adjusted, and if necessary account for reasonable utility costs.

Opportunity Home will maintain a record that documents the basis on which the flat rents are established and revised and the record will be made available to residents upon request. The current flat rent schedule will be available for review by residents at homesa.org or by visiting a Public Housing community office.

Opportunity Home will place a cap on any increase in a family's rental payment that exceeds $35 \%$ and is a result of the changes to the flat rental amount as follows:
